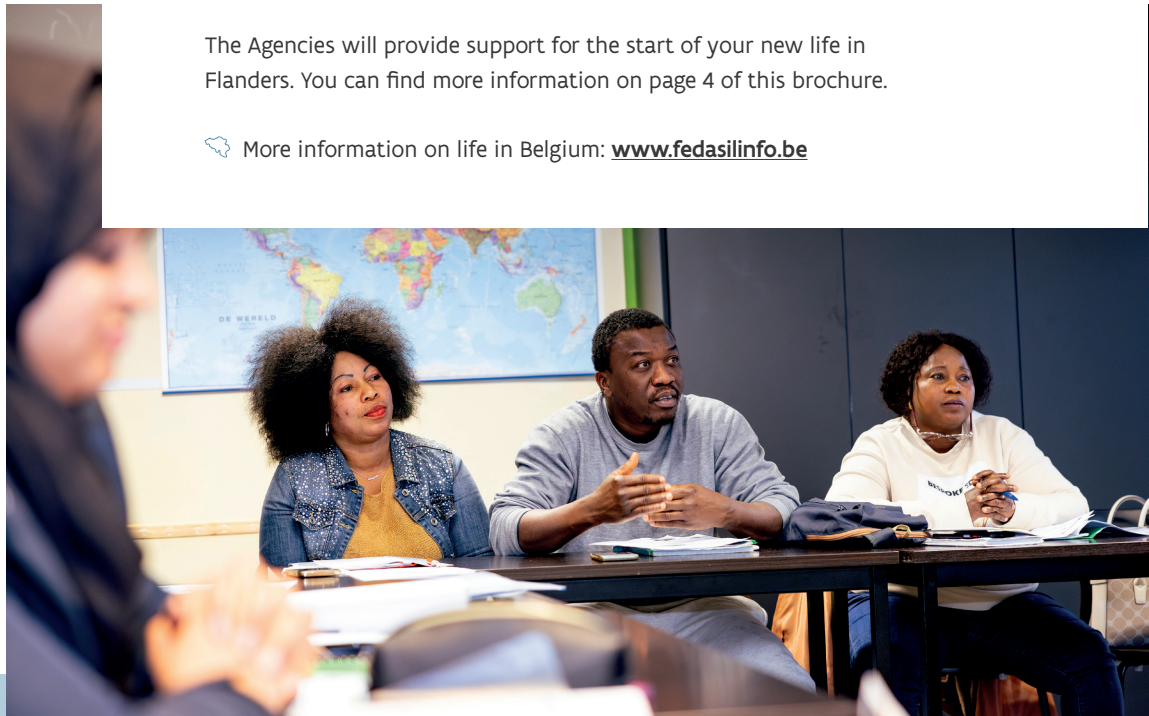
If you would like to know more about these topics and life in Belgium

You are new to Flanders. The **civic integration programme** will help you find your way around in a new country, so you will feel at home faster.

- The social orientation course will teach you about life in Belgium. You can attend classes in your own language or in a language you understand well.
- We will help you find a Dutch language course that suits you. You will also receive tips for practising the Dutch language.
- If you are looking for a job or a course, we will listen to your ambitions. You can register with the VDAB and get support in finding a job or a training course.
- You will meet new people and participate in social activities during the participation programme.

Throughout the programme, you will receive individual counselling and information in your own language or a language you understand well. A programme counsellor will coach you throughout the programme.

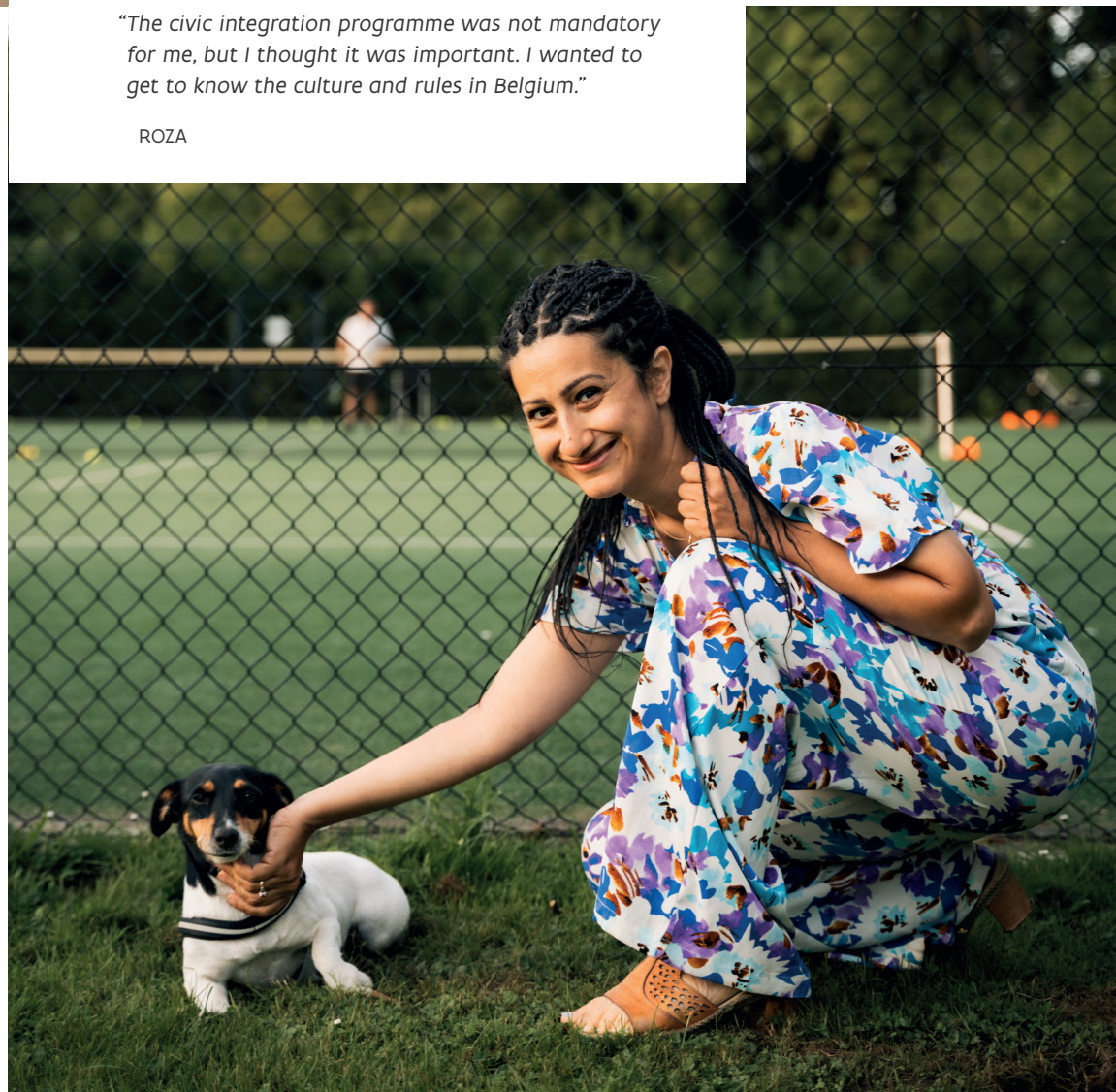

Your municipality

Town Hall

You must register in the city or town where you live. You can do so at the town hall. Every municipality has a town hall where you can obtain official documents: residence documents, registration in the municipality, change of address, proof of birth, driving license ...

Your residence documents must be in order. In many situations, you will need a valid identity document. For example: to rent a house, to work, to go to the doctor, to start the civic integration programme...

At the town hall, you can also find information about leisure activities, sports, library, etc. For more information, check your municipality's website.



Do you have financial or other difficulties? Do you need administrative and social assistance?

Go to your municipality's Sociaal Huis (social house) (OCMW). Social services will assess how they can help you.

Work and training

How to find a job

If you do not have a job yet, VDAB or the OCMW (if you are on a leefloon [social integration income]) will help you find a job. Register as a job seeker at VDAB. You can do so online or at a VDAB location. You can find an overview at www.vdab.be/contact.

IF YOU ARE PARTICIPATING IN THE CIVIC INTEGRATION PROGRAMME

you must register with the VDAB within two months (if you have not already done so).





Studying

Where can adults study in Flanders?

- You can attend a course at a Centrum voor Volwassenenonderwijs [adult education centre] (CVO).
- You can attend a course at Ligo, a Centrum voor Basiseducatie [basic education centre].
- You can pursue higher education at a university college or a university.
What do you need?
 - a secondary education certificate.
 - some universities and university colleges may require a Dutch language test, such as ITNA: www.itna.be.

Diploma recognition

Did you obtain a diploma in another country than Belgium? You can have your diploma recognized in Flanders at NARIC-Vlaanderen (National Academic Recognition Information Centre). The recognition procedure is complex.

If you are participating in a civic integration programme, AgII, Amal or Atlas can assist you with the procedure. A recognized diploma opens more opportunities to find a job or to pursue further studies.

School for your child

In Belgium, education is compulsory for all children aged 5 till 18. Compulsory education starts on 01 September of the year in which your child turns 5. From that day forward, your child must receive tuition. Most children start school between the ages of 2.5 and 3. You can choose a school yourself.

Preschool	Primary school	Secondary school	Higher Education
Ages 2.5 - 6	Ages 6 - 12	Ages 12 - 18	From 18 years of age

Groeipakket (growth package)

In Flanders, you receive monthly financial support for the upbringing of your child(ren). This is called the Groeipakket. The amount depends on your personal situation.

Housing company

Is renting an apartment or a house financially impossible for you? You can rent a social housing unit. The rent will be lower in that case. There are specific requirements to be eligible for social housing. A housing company will assess your situation.

Do you qualify for a social home? You will be placed on a waiting list.

Finances

Payments

Cash and bank cards are accepted everywhere in Belgium as means of payment.

Did you know that... everyone in Flanders is entitled to a basic bank account including a bank card? This allows you to:

- make electronic payments in stores.
- withdraw and deposit cash in Belgium.
- transfer money.
- request statements from your account.



BEWARE:

- You cannot make deferred payments with the basic bank account.
- You cannot borrow money with the basic bank account.
- If your balance is 0 €, you cannot make payments anymore.

Do you want to open a bank account in Flanders?

You can choose with which bank in Flanders you open your first account.

You have the choice between a basic bank account and a regular bank account.





What do you need to open a bank account?

- your electronic identity card or residence document. You need to prove your identity.
- a letter from the municipality to pick up your identity card or residence document, or a certificate from the municipality. You must prove your address.

Are you having financial problems?

You can contact your municipality's Social House (OCMW) for financial support. You can apply for a leefloon [social integration income] if you temporarily have no or a limited income. A leefloon is a monthly financial aid. They can also help you with, for example, high energy costs, school expenses...

Can everyone with financial problems receive a leefloon?

No. You must meet specific conditions. You apply at the Social House or the OCMW. They will assess whether you are eligible for a leefloon.

Health and Well-being

Are you ill?

See your family doctor. The family doctor (or general practitioner):

- is your primary contact for medical questions;
- manages your medical records;
- examines you;
- can refer you to a specialist.

Using the app, you can contact the fire department, an ambulance, or the police directly. The app instantly makes your location visible to the emergency responders.



Caution

Health insurance is mandatory in Belgium. This insurance is important as it helps you cover medical expenses.

 **TIP** | With HZIV (Hulpkas voor Ziekte- en Invaliditeitsverzekering) [aid fund for sickness and disability insurance], you can have the mandatory insurance at no extra cost.

Mobility

Public transport

In Flanders, you can take trains, trams, and buses to get around. Always buy a ticket before getting aboard. Validating your ticket is mandatory. Scan your ticket every time you board a tram or a bus. If you do not have a valid ticket, you will get a fine.

Where can you buy a ticket? You can buy your ticket at a counter in the railway station, from a ticket vending machine or using your mobile phone. On trams and buses, you can also pay by bank card.

Driving licence

You need a valid Belgian or international driving licence to drive in Belgium. Do you have a valid European national driving licence? You can use it to drive in Belgium. You do not need to exchange it for a Belgian driving licence (as long as it remains valid).

Do you have a driving licence from a non-EU country? You can only drive in Belgium for 185 days with that license. After that, you can use it to apply for a Belgian driving licence.

 **BEWARE:** Not all driving licences can be converted into a Belgian driving licence. Here is the list of recognized non-EU countries:



Where can you apply for a Belgian driving licence?

You can apply for a Belgian driving licence at your town hall (See page 9). The procedure takes several weeks or months.

You do not have a driving licence yet?

You will have to take a driving test.

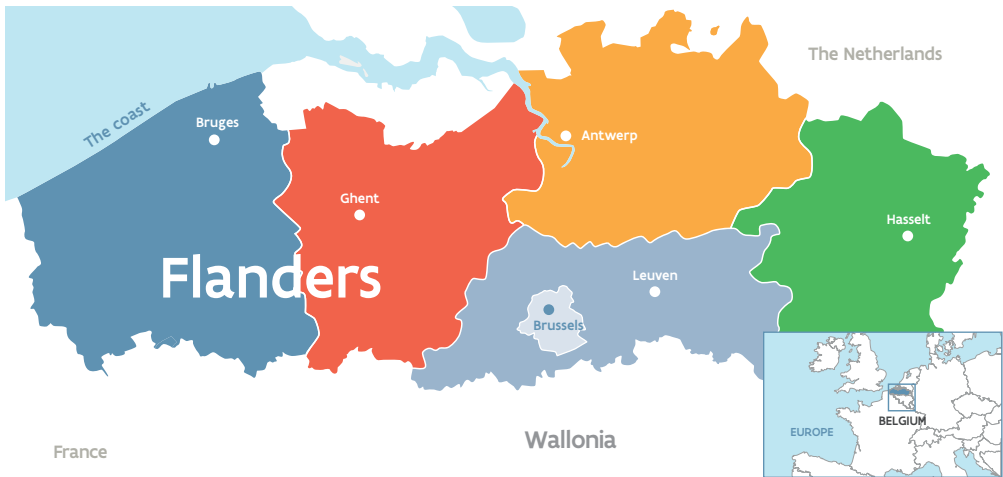

Brussels is the capital of Belgium. Belgium has 3 regions: Flanders, Wallonia, and Brussels.



In Belgium, you pay in **Euros**.



The official languages in Belgium are **Dutch, French, and German**.



Belgium is a **kingdom**. The head of state is **King Filip**. His wife is Queen Mathilde.



Belgium is a **democracy**. People in Belgium can have a say in policy decisions.
